Assist in cleaning of the aquatic facility, deck, and other areas as directed by the aquatic supervisor.

Respond to the public needs in a courteous manner and report comments/complaints regarding to physical facility, staff or general public to supervisor.

Education and experience:

Currently enrolled or have graduated from high school or GED program. Previous lifeguard experience preferred.

Clarity of vision at 20 feet - corrected or uncorrected.

Ability to pull and remove persons from the water.
